- **Welcome**

 - Approval of the Minutes from the July Meeting

 - Financial Report: Lauren mentioned that more than \$6,000 was given out in Façade Grants during the current fiscal year. Last year, only \$1,500 was given out in Façade Grants.
- **Old Business**
 - Downtown Mural
 - Lauren stated that she had sent out an RFP for the mural on the side of Pex Theatre. The RFP will be sent out to Board Members so they can share it with any artists they know. Lauren said that she did send it to the members of The Artisans Village.

 - After the success of the previous Rise & Shine Meeting in Prime Time, it was determined that the next Rise & Shine Meeting should also take place in Prime Time. The date was set for October 25th at 6:30pm at The Eat-A-Ton Café, if they are open at the time.

- Property on S. Maple Street (Lot 1 & 2) has sold for \$25,000
 - Listing price was \$60,000
 - Property is 0.34 acres
 - New owner is Shirlon Mathis, who owns Southern Delight Cafeteria
 - FMB has owned the property since 1983
- The Rabbit’s Hole may open on August 15th
- Most Valuable Smiles opened at 122 W. Marion Street
 - Dentist office of Dr. Willie Oliver
- Pretty Girlz Fitness opened at 116 W. Marion Street
 - Former location of STEAM Kids and Grace STEAM Academy
- 104 E. Marion Street, Suite B has been leased
 - Opening date unknown at this time
 - *“Our business will be an addition to the evolving downtown area servicing the diverse community it houses. I have always had a passion for inclusivity and giving back, and this space will not only have the communal spot for connection, but showcase the multitude of local artists and makers from around. We are making a hybrid of a boutique and bar (both coffee and alcohol) and essentially providing a mix of services to those coming in.”*
